DUE TO THE WOVEN CHARACTERISTICS AND THE SEWN SEAMS OF THIS POOL COVER, WATER WILL SEEP FROM THE POOL ONTO THE TOP OF THE COVER. DURING THE OPENINGS OF YOUR POOL, WHATEVER MEANS OF SUCTION USED TO REMOVE THE WATER FROM THE COVER SHOULD NOT BE RESTING ON OR POINTED TOWARDS THE COVER. THIS WILL REDUCE POOL WATER BEING SUCKED THROUGH THE COVER.
